Information on changed/new rules and policies

The Secretary General informed the Members that art. 6 of the Rules of Procedure has been changed and that art. 19 and 20 were new. Changes and new rules were accepted by the Board.

a) Rule 6: Affiliation to other organisations

Adapted rule (changes in Italic):

"International or national organisations with similar or related aims may apply for affiliation to the ESC. Members of affiliated societies shall pay a 50 percent reduced yearly fee (suggested by the EC, approved by the Board). Those seeking affiliation must submit an application in writing to the Secretary General. The Board shall ratify the final affiliation. This decision shall be followed by a signed contract including rights and duties of members of affiliated societies. The Central Office of the ESC

shall receive a complete list of members including email and postal addresses from the affiliated Society. *Members of affiliated societies have the same rights as other ESC members including voting rights during the GA.*

Members of affiliated societies are entitled to:

- a) receive a hard copy or an electronic form of the Journal of the ESC
- b) receive an electronic form of the Newsletter
- c) receive information about seminars, congresses and other meetings organised or supported by the ESC
- d) free attendance at ESC seminars
- e) preferential registration rate at ESC congresses

Affiliated societies will:

- a) inform the Secretary of the Central Office of any change of address
- b) pay a yearly subscription"
 - b) New rule (nr 19): ESC sessions during other congresses:

"Besides regular seminar and congresses the ESC may support a speaker or organize a session during national or international congress of societies with similar aims as the ESC. Requests are collected by the Central Office. The Central Office is responsible for the negotiation about financial aspects of the participation. A maximum of 7 % of the income from the last Congress is dedicated each year to cover expenses of ESC speakers. The EC is responsible for the final selection of meetings which will be supported, according to the budget available. The ISC is responsible for the preparation of the scientific programme."

c) New rule (nr 20): Committee of Past Presidents:

"The ESC Committee of Past Presidents consists of all past ESC presidents on a voluntary basis. The essential role of the Committee is to assist in ensuring continuity and stability in the life of the ESC. The activities of the Committee are limited to providing advice and proposals. The Committee will, when requested, be the "Ambassador" of the ESC towards European or international institutions dealing with contraception or reproductive health. Special attention should be paid to establishing contacts and collaboration in European countries which are not yet represented in the ESC. The Committee could help or even negotiate in the case of serious problems with ESC representatives or within the Society. The Committee can send one member to participate in Board meetings but with no right to vote. The committee meets every other year during the ESC congress and produces a report to the Board. Members are invited by the ESC. Continuation of the Committee will be evaluated by the Board after the next two congresses ie 2012."

d) Involvement of ESC officers in industry symposia

(policy, no new rule)

ESC Officers are not allowed during an ESC Congress or Seminar or other ESC sponsored event:

- 1. To chair sponsored sessions
- 2. To do presentations on product-oriented topics

3. To do a presentation in sponsored symposia which are in parallel to the major official programme

Change of the name of the Society

The President stated that, looking at our activities, projects and area's of interest, it is clear that our society is dealing and interested in much more than contraception only (abortion, sexuality, education, STI, ...).

The Executive Committee and the Board of Directors therefore asked the ESC members to vote for changing the current name of the society 'European Society of Contraception' to 'European Society of Contraception and Reproductive Health '. The abbreviation would remain 'ESC'.

The decision should be approved on a majority of two thirds.

The ESC Members were asked to raise their hands to indicate acceptance or rejection. The change of the name of the Society was accepted unanimously.

Review of ESC accounts

art X of the Statutes: "The written statement of accounts will be reviewed and countersigned as a true and fair view of accounts every two years by two members of the Society from separate countries who are not on the Board. The General Assembly will vote on these nominations by simple majority."

Review of the financial report at the GA in Istanbul has been signed by two ESC members: I. Batar (Hungary) and R. van Lunsen (The Netherlands).

P. Krepelka (Czech Republic) and K. Bakalianou (Greece) volunteered to revise the GA Financial report 2008. The GA agreed unanimously on these nominations.

Science, education and other projects

1. Internal Scientific Committee - ISC (report by Dan Apter)

Mandates

- G. Bartfai and V. Unzeitig cannot be re-elected as they will no longer be Board members and need to be replaced in the ISC. Elections will be organized during the meeting of the new Board on Saturday 3 May 2008.

New applications for ESC support

a) Applicant: Society for Family Planning and Sex Education - Czech Family Planning Association

Project: Sex Education and Enlightenment for Mentally Disadvantage People. The aim of the initiative is to enable mentally disadvantaged people to exercise their human rights to sexual and reproductive health in the same manner as other population do and to have equal access to appropriate information and education about sexuality and sexual and reproductive health and services. To reach this aim it is necessary to educate and train the personnel who provide services to mentally disadvantaged clients.

Decision proposed by the ISC and approved by the Board: applicant must submit a pilot project including the required budget.

b) Applicants: Marta Szucs (Hungary), K. Sedlecky (Serbia), G. Bartfai (Hungary), I. Blidaru (Romania)

Project: Questionnaire - What do women think about menstruation? (Sample size: 400 students)

The application was accepted by the ISC and approved by the Board.

c) Applicant: Research and Prevention for Families Foundation (RPFF), Hungary

Project: Conference - 1st Central and Eastern European Summit on Preconception Health and Prevention of Birth Defects, Budapest, Hungary, August 27-30, 2008.

The ISC did not approve this bid due to the fact that the conference theme is beyond the scope of the ESC. The Board agreed and decided not to support the application.

2. Expert Groups

Structural

In principle, each group should have at least one seat for a Board member. Because of the changes in the Board since Istanbul, quite a lot of members of the Expert Groups are no longer Board member. Some of the groups are without Board member representation. This point has been discussed by the Board in Bucharest and it was agreed not to replace existing members. One good reason not to replace them is that all groups are in the process of working on different projects. However, it was agreed that each expert group should have at least one Board member represented. Elections will be organized during the meeting of the new Board on Saturday 3 May 2008. Each group has a coordinator who is the group leader.

19 to 22 May 2010

Theme: Culture, Communication, Contraception

R. Beerthuizen and Rik van Lunsen, hosting organizers, briefly introduced the congress and invited the members to attend the next edition of the ESC Congress.

Bids to host the 2012 Congress

- D. Cibula reported that bids have been received from:
- Denmark, Copenhagen (S. Skouby)
- Greece, Athens (D. Lazaris and N. Salakos)
- Italy, Milan (P. Crosignani)

After a short presentation of the three proposals, the bids were subject to voting by the General Assembly.

At the first count the results were:

Denmark - received 92 votes Greece - received 86 votes Italy - received 36 votes

Total: 214 votes

The President explained that the General Assembly takes its decisions by simple majority. He defined 'simple majority' as 50 percent + 1 vote not simply 'the country with the most votes'.

As there had not been clarity as to which type of voting was being undertaken, the GA was asked to vote on the 2 voting mechanisms:

A] the country with the most votes after round 1

B] 50 percent + 1 vote

If Option B was chosen, there would need to be a second round of voting as Denmark had not achieved 50% + 1 vote.

The President also advised that members could use their proxy votes.

The results were:

Option A] 'Stick to the first round decision' 114 votes

Option B 'Decide by means of a second round of voting' where only the 2 highest contenders are included: 120 votes

Total votes: 234

It would appear that some members did not use their proxy vote in the first round of voting

A second round of voting was held:

The results were:
Denmark – received 101 votes
Greece - received 120 votes
Total votes 221

It was therefore decided that Greece (Athens) will be the destination for the 2012 ESC Congress.




